There are over sixty active ERA-NETs, six Article 185 initiatives, ten Joint Programming Initiatives (JPIs), and four European Joint Programme Cofunds (EJPs); for an overview see our website jointprogramming.nl. Joint Programming in Horizon Europe

The first draft of FP9 for Member State consultation is expected tomorrow. Under the 9th Framework Programme for research and innovation - Horizon Europe - the number of instruments will be reduced. Partnerships will be a core of FP9 and the concept European Partnership Initiatives will be introduced. EPIs have three funding instruments: CSA, Co-fund and Art. 185/187. The JPI Chairs Conference "10 years Joint Programming Initiatives - achievements and the way forward" which will take place in Vienna on 19 and 20 September 2018 under Austrian Presidency is timely. A common position and planned joint actions will show the specific perspective of JPIs on the more general EPI context and their contributions in the coming years.

FACCE-JPI / Belmont forum joint action

FACCE-JPI and the Belmont Forum are exploring conditions and scope for collaboration on climate change and food systems. A joint meeting is organised in Brussels on 18 and 19 June 2018. This workshop is meant for key persons involved in FACCE-JPI, the Belmont Forum and LEAP-AGRI (the long-term EU – Africa research and innovation partnership on food and nutrition security and sustainable agriculture).

BONUS in the European Parliament - Science for sustainability in regional seas and beyond

Art. 185 initiative BONUS (the joint Baltic Sea research and development programme) and Member of the Parliament Miapetra Kumpula-Natri organised a “BONUS in the European Parliament” event in Brussels on 16 May 2018. It built on the conclusion of the independent final evaluation of BONUS published by the EC in October 2017, and consisted primarily of two panel discussions. The first panel presented results of the BONUS’s policy-driven research and development programme. The second panel discussed the plans of forming a joint Northern European research and innovation programme of the Baltic Sea and the North Sea based on the BONUS model (BONUS 2). The Netherlands Organization for Scientific Research (NWO) is one of the participating partners preparing BONUS 2.

Research and knowledge on biodiversity and ecosystem services

DG R&I in collaboration with the EKLIPSE project organised a workshop on 1 June in Brussels on “Research and knowledge on biodiversity and ecosystem services: from global to European level and vice versa”. Main goal was to discuss how these issues can be best included in the planning of the next Framework Programme (Horizon Europe). Participants were from European and national public institutions and programmes, including the ERANET BiodivERSA and three JPIs (Water, FACCE, Climate).

The SCAR CASA project supports a series of national meetings to increase visibility of the Standing Committee of Agricultural Research (SCAR) in Member States, promote SCAR outcomes, provide a forum for exchange of national relevant background, and foster involvement of different stakeholders at the national level. In April and May three national meetings have taken place; in Hungary (Budapest, 25 April 2018), Greece (Athens, 24 May 2018), and Italy (Rome, 29 May 2018). 

SCAR ARCH study on global implications of the European Food System

The SCAR Strategic Working Group ARCH commissioned a study on the global implications of the European food system. The report of the study entitled “Global implications of the European Food System – A food systems approach”, completed by a team from Wageningen UR (Petra Berkhout, Thom Achterbosch, Siemen van Berkum, Hans Dagevos, Just Dengerink, Arie van Duijn, and Ida Terluin), is now available. It zooms in on the trade relations between the EU and the rest of the world and the effects of this on local food systems, based on social, environmental and economic indicators.

SCAR FOREST study on ERA-NETs and COST Actions in the EU forest-based sector

The SCAR strategic working group on forests and forestry research and innovation (SCAR SWG FOREST) commissioned a study on the impact of past and existing ERA-NETs and COST Actions within and related to the European forest-based sector. The report “Assessment of ERA-NETs and COST Actions in the EU forest-based sector” is now available. The PLATFORM Database was an indispensable source of information for the study. The results of the study highlight the importance of the ERA-NET and COST funding schemes to initiate and implement future-oriented forest-related research and innovation projects through transnational networks and collaborative actions.

The aim of the workshop was to extract new ideas which can stimulate reflections at policy level for tackling global challenges for Seas and Oceans, and inspire decisions of the Management Board of JPI Oceans.


News on Joint Calls



JPIAMR Network Call on Surveillance 2018 open

The Joint Programming Initiative on Antimicrobial Resistance (JPIAMR) has opened a network call that will support networks of leading experts to enhance resource alignment and maximise efforts to combat AMR by pushing forward the conceptualisation of new ideas within the field of AMR surveillance. Up to 21 networks will be funded up to €50 000 each. Ten JPIAMR member countries are participating in this call, including The Netherlands (ZonMW / NWO). Submission of proposals closes on 12 June 2018.

JPIAMR-VRI Network Call 2018 open

To address the need to reinforce alignment of research, the JPI on Antimicrobial Resistance (JPIAMR) will establish a Virtual Research Institute in AMR (JPIAMR-VRI), a global network connecting research performing organisations. The intent of the JPIAMR-VRI Network Call is to help develop a platform that will identify research community needs in AMR and develop ideas to form the foundation of the JPIAMR-VRI. Like the network call on surveillance (see news item above), the VRI call will fund at maximum 21 networks up to €50,000 each. There are 10 countries participating in this call, including The Netherlands (ZonMW). Submission of proposals closes on 4 July 2018.



First results Water JPI 2017 joint call

67 Pre-proposals have been submitted to the Water JPI call on "Water resource management in support of the United Nations Sustainable Development goals (UN SDGs)" which closed in December 2017. 37 Consortia have been invited to submit a full proposal by 27 June 2018. The call will be funded by 12 funding organisations under the Coordination and Support Action IC4WATER which has the aim to implement Joint Activities dedicated to the development of international cooperation in the area of water challenges. The Netherlands does not participate in this call.

Six projects awarded in Making Cities Work call

In April six projects were awarded in the Making Cities Work call of JPI Urban Europe. This call invited municipalities, businesses, researchers, civil society and other stakeholders to build transnational consortia to create challenge-driven innovation projects for European urban areas that have the potential to result in commercially successful services and products. Six funding agencies from five countries (Austria, Belgium, Finland, Norway and Sweden) are involved in this call.

The EU Joint Programme – Neurodegenerative Disease Research (JPND) has awarded funding to ten research projects to perform new network analyses in order to better understand the common underlying mechanisms involved in neurodegenerative diseases. Of the ten consortia funded through the call for "Multinational research projects for Pathway Analysis across Neurodegenerative Diseases", one is coordinated by a Dutch partner and six others include a Dutch partner.

International workshop "Nature based solutions for urban resilience"

The Urban Europe Research Alliance (UERA), a key initiative of JPI Urban Europe, and IEFE-Bocconi are organising an international workshop on "Nature based solutions for urban resilience" in Milan on 5 June 2018. The aim of the workshop is to analyse and compare applications of planning, evaluation and management approaches to nature based solutions at urban scale, and to assess their impacts in terms of economic development, environmental conservation, improved social cohesion and stakeholder engagement.

Kick-off projects "Sustainable Urbanisation Global Initiative/ Food-Water-Energy Nexus" call

The interactions between food, water and energy are of paramount interest to policy, science and the society at large. In order to bring together actors to find innovative solutions to the Food-Water-Energy nexus challenge, JPI Urban Europe and the Belmont Forum opened a "Sustainable Urbanisation Global Initiative (SUGI)/Food-Water-Energy Nexus" call in 2016. In November 2017, 15 projects were selected for funding. Seven of these include one or more Dutch partners. Wageningen University is partner in two projects. The projects will start during the first half of 2018, and the kick-off meeting will take place in London on 11 and 12 June 2018.




